- 5. ****Dana Matthews, on behalf of New Venture of Destin, LLC, is requesting approval of a Development Agreement Amendment relating to the property located at 15,000 through 15,600 Emerald Coast Parkway (Lots 1 through 8B, Silver Shells Beach Resort, A Planned Unit Development) in the City of Destin. The currently approved development agreement contains a multi-family mixed use planned unit development. The project includes a clubhouse, a maximum of 587 units in six buildings at a height ranging from 160' to 190' above mean sea level, a population density of 1,468, a Floor Area Ratio of 1.34 and 29.28 acres more or less. The Development Agreement Amendment provides for vacating the public's right to use the existing 26 space parking lot currently located on the Silver Shells project site and constructing 26 new public parking spaces and associated sidewalk, landscape islands and storm water retention area with the right-of-way of Restaurant Row.
