DESCRIPTION

BEING A RESUBDIVISION OF THE FOLLOWING DESCRIBED PORTIONS OF "SECOND REVISION OF CALHOUS SUBDIVISION OF ADDITION TO TOWN OF DESTIN, FLORIDA, OKALOOSA COUNTY, FLORIDA," AS RECORDED IN PLAT BOOK 2, PAGE 43A, RECORDS OF OKALOOSA COUNTY, FLORIDA;

THE EAST 140.0' OF BLOCK F-1; THE SOUTH 125.0' OF BLOCK F-6; THE SOUTH 125.0' OF BLOCK F-5; THE NORTH 125.0' OF BLOCK F-9; THE NORTH 125.0' OF BLOCK F-10 EXCEPT THE WEST 8.0'; AND THOSE PORTIONS OF MAGNOLIA AVENUE AND SAIL FISH STREET LYING BETWEEN THE ABOVE DESCRIBED LANDS AND THAT PORTION OF MAGNOLIA AVENUE LYING BETWEEN THE EXTENDED EAST AND WEST RIGHT-OF-WAY LINES OF SNAPPER STREET; AND THE EAST 30.8' OF THE SOUTH 125.0' OF THAT PORTION OF DOLPHIN STREET LYING WEST OF BLOCK F-5.

BEING MORE PARTICULARLY DESCRIBED AS: BEGINNING AT A CONCRETE MONUMENT MARKING THE NORTHEAST CORNER OF BLOCK F-1 OF SAID SECOND REVISION OF CALHOUS SUBDIVISION, PROCEED SOUTH 804.6' ALONG THE WEST LINE OF BENNING DRIVE, THENCE WEST 140.0', THENCE NORTH 688.2' PARALLEL TO BENNING DRIVE TO STAHLMAN AVE., THENCE NORTHEASTERLY ALONG STAHLMAN AVE 181.9' TO THE P.O.B.

AND: BEGINNING AT A CONCRETE MONUMENT MARKING THE NORTH WEST CORNER OF LOT 2, BLOCK 2 EASTWOOD ADDITION TO DESTIN, AS RECORDED IN PLAT BOOK 4, PAGE 7, RECORDS OF OKALOOSA COUNTY, FLORIDA, PROCEED WEST 730.3', THENCE SOUTH 208.0', THENCE EAST 27.9', THENCE SOUTH 142.0', THENCE EAST 700.0' TO A CONCRETE MONUMENT MARKING THE SOUTH WEST CORNER OF LOT 8, BLOCK 1 OF SAID EASTWOOD ADDITION, THENCE NORTH 250.0' TO THE P.O.B.

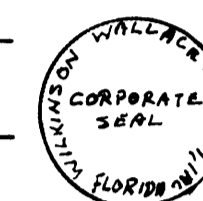

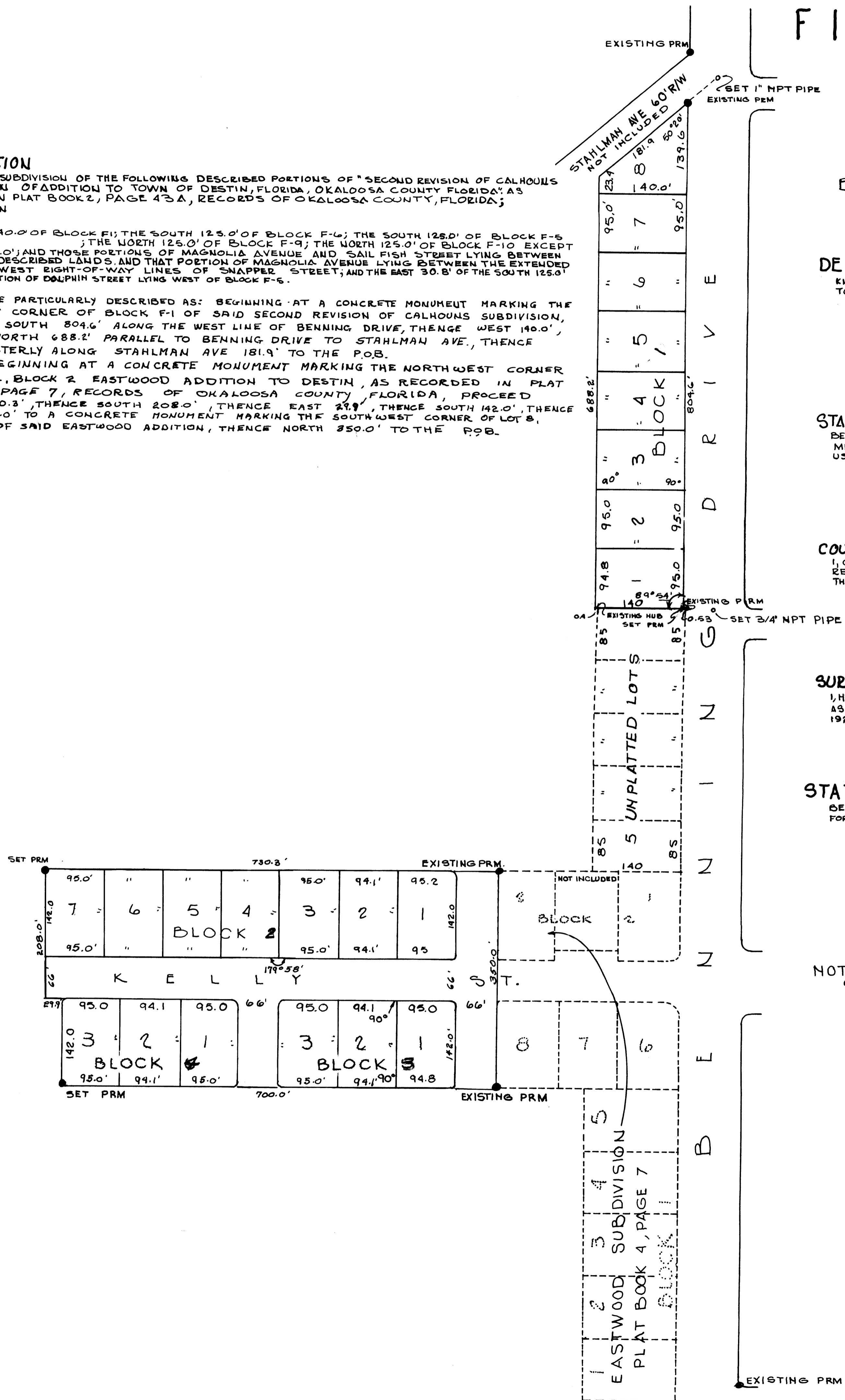
