**CITY OF DESTIN
PLAYER/TEAM CONDUCT AND RAIN OUT POLICY**

1. Teams will NOT be put on the schedule until team sponsorship fees are paid.
-\$300 per team
2. Individuals will NOT be allowed to play until their individual fee is paid and they have signed a waiver.
-individual fees: \$40/non-Destin Resident and \$20 discount for proof of Destin Resident.
3. If a player is ejected before, during, or after a game, that player must leave the facility, and will not be eligible to play until their suspension is served (minimum of one game). If a player is ejected twice in one season they will be suspended from playing in Destin for the rest of that season.
4. No foul language, un-sportsmanlike conduct, or verbal threats will be permitted. Officials, Scorekeeper, or Supervisor, if deemed necessary, can suspend a player from the game or stop the game until order is restored. If a player is involved in a fight he will be ejected from the league and cannot participate in any Leagues or Tournaments run by the City of Destin Recreation Department for one calendar year from the date of the ejection.
5. No alcoholic beverages allowed at the fields or in the parking lots. Any player who violates this City Ordinance will be suspended for one game. Subsequent violations will result in the team forfeiting the next game.
6. If the lightning detection system alerts due to inclement weather in the surrounding area, all games are stopped and all players must clear the playing field and seek shelter in their vehicles. Play will resume after the all clear alert is sounded.
