DYSL Official 4 & Under Playing Recommendations

Law 1 – Field of Play

Length - 50 yards **Width** – 30 yards

Field Markings – center circle 5 yard radius

Goal area – Measuring 5yds by 12yds **Penalty Area**- None

Goals- “8 x 6.5” **No Goalkeepers**

Law 2 - Ball - Size 3

Law 3 - Number of players – 6 on 6. Substitutions- at any stoppage and unlimited playing time - every player plays a minimum of 50 % of every game

Law 5 – Referee - 1 parent/coach from each team- Don't stand near goals!

Law 7 - Duration of the game - 4 x 5 minute quarters. Two minutes break between each quarter

Law 8 - Start of Play - kick- off- opponents must be 4 yards from ball

Law 11 - Offside's- None

Law 12 - No Fouls are called. Coach will assist in restart of play

Law 14 - Penalty Kicks- None

Law 15 - Throw-ins - Yes. Opposition must be 4 ft. away minimum

Law 16 - Goal Kicks - Taken with 2-3 yards of the goal line anywhere across the field- at the closest point to where it went out of bounds.

Law 17 - Corner Kicks – As normal except opposition must be a minimum of 4 yards away

Advantages of playing Small-Sided Games

- >More time with the coach
- >Energetic workouts due to playing both offense and defense
- >Matches can be played simultaneously across a full-sized field
- >children are physically more efficient in smaller space
- >Children are actively involved for a longer period of time
- >It takes less time to score a goal or advance to goal
- >Greater success rate for the players

US Youth Soccer Recommendations

- Opposing coaches, players and parents should shake hands after every match (Parent's Tunnel)
- Parent/Coaches, spectators should be there to enjoy and encourage
- No slide tackles
